ORDER

Government permit Sri Vasavi Kanyaka Parameswari Arts & Science College Committee, Panugonda to start a private Degree College Temporarily for a period of one year during 1974-1975 at Panugonda in W.G.Dist.

The permission accorded in para.1 above is subject to the following conditions:-

- a) The Management should run the college without any Government Grant either now or in future.
- b) The Management should deposit Rs.2.00 Lakhs immediately and a further sum of Rs.2.00 lakhs within six months under the Joint Account of the Director of Public Instruction and the Chairman of this College Committee. The amount stipulated is in addition to the Corpus Fund to be deposited according to the instructions of the University concerned.
- c) The Management should fulfil all the conditions stipulated by the University in regard to accommodation equipment, staff, Library and play ground etc.
- d) The College may collect tuition fee as decided by the Management under the rules laid down in the A.P. Educational Rules;
- e) The Committee should allow fee concessions etc., to S.Cs and S.Ts and other Backward Classes as per the Rules in force and the amount covered by such concessions will be reimbursed by the Government subject to the budget provision available in this regard and according to the rules prescribed by the Government from time to time.
- f) The Management should provide temporary accommodation to. locate the college and provide pucca buildings as early as possible and also to provide 30 to 40 acres of land for the College.
- g) The Management should take necessary action to obtain affiliation of the University concerned;
- h) The Management should follow the Rules issued by Government from time to time in regard to reservation for SCs, STs and other Backward classes in respect of admissions and the appointment of staff;

- i) The College shall open with 1st year Degree Courses in B.A and B.Sc.
- j) Telugu should be the medium of instruction in the courses introduced.
- k) The Degree College should be a separate Unit.

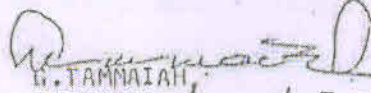

INSPECTION REPORT DATED 30-7-74 OF THE UNIVERSITY
COMMISSION ON THE PROPOSAL TO START A DEGREE COLLEGE
AT PENUGONDA.

In accordance with the Registrar's letter No. C.II-(1)/29223/74, dt:17-7-74, the University Commission visited Penugonda on 26.7.74 to conduct local inspection of the ~~pro~~ proposed college, the site, buildings and other physical facilities available for starting B.A., B.Sc., and B.Com., degree courses from the year 1974-75 and recommended on the application of the S.V.K.P.College Committee.

The S.V.K.P. College Committee secured permission from the Govt. of Andhra Pradesh to start a Junior College from 1974-75 with two sections of eighty students each, one section for science (Physical science + Maths and Physical Science + Biological Science) and another for Arts Courses. In the permission given by the Education Department Andhra Pradesh, The College Committee was directed to "Open the 1st year ~~xx~~ degree courses in B.A., and B.Sc." The Committee now proposes to seek affiliation for the following courses:

The student potential

The Commission examined the student potential in and around Penugonda. At present there are the following Junior College within 15 miles with the student strength as shown below:

<u>Name of the Junior College</u>	<u>Distance</u>	<u>Student strength</u>

If the pass percentage is taken as 50% on an average per year, the number of students seeking admission will be approximately 170-325. Since the distance is large, the students seeking admission may need hostel facilities also.

It may be also pointed out that the Junior College proposed to be started this year will have a student strength of 160 only and approximately about 80 of them will be seeking admission two years hence from now. There are 15 high schools within a radius of 5 miles from Penugonda to maintain the student strength at the Junior College. Hitherto, the students of Penugonda are handicapped for continuing their education after S.S.C., and only rich students could go to distant places like Tanuku, Bhimavaram etc.,

The University Commission felt that there is a real necessity for starting a Junior College immediately along with a degree college.

THE COLLEGE SITE AND THE PERMANENT BUILDING:

The S.V.K.P. College Committee proposed to take an area of 22.00 acres on long lease from the S.V.K.P. Devasthanam and build the permanent building on this area. The metal approach roads will also be built at the same time. This site around which the Commission was taken, is about half a mile away from the town of Penugonda and also from the nearest main road which connects with Siddhantam and Sletipadu and others.

With reference to your letter cited above, the Inspection Commission consisting the following members visited Sri S.V.K.P. Arts & Science College, Penugonda on 3rd May, 1979 in connection with the request of the College for the grant of Permanent Affiliation for B.A. and B.Com. courses.

1. Prof. K.V. Ramana (Convener), Head of the Dept. of Economics.
2. Prof. S. Alwar Das, Syndicate Member.
3. Prof. V. Balmohan Das, Commerce Department.

The Principal of the College, President and the Correspondent of the College Committee, a few other members of Governing Body and some Teaching Staff members were present at the discussions with the Committee.

The Management informed the Committee that it has already acquired 7.5 acres of land for buildings, play ground etc. The Committee also informed that they have plans to acquire two more acres of adjoining land and they are already negotiating with the owners of the above land. The College has presently sufficient accommodation and constructed pucca sheds-tiled roofing for running classes, for the Library, Staff room and girls waiting room.

The Committee found that adequate qualified teaching staff have been recruited for running the degree classes both in B.A. and B.Com. courses as per the norms of the work load.

The college has built-up a Library with copies of the important books in all the subjects offered in B.A. and B.Com. courses.

The Management has already deposited Rs. 2 lakhs with the State Government as Corpus fund and they have spent nearly Rs. 2 lakhs on the construction of buildings, acquiring furniture for the class rooms etc. The Management informed the Committee that they are collecting a levy from the paddy growing farmers regularly which will enable them to meet the recurring expenditure of the college. This course provides a sound financial base for running the college.

In view of the satisfactory financial position of the college with adequate accommodation, qualified teaching staff and with the necessary library facilities, the Committee recommends for Permanent Affiliation for one section in each B.A. and B.Com. This will facilitate the College Management to approach the Government and the University Grants Committee for grants under various schemes.

The Committee expresses thanks to the management, the Principal and other staff for their hospitality.

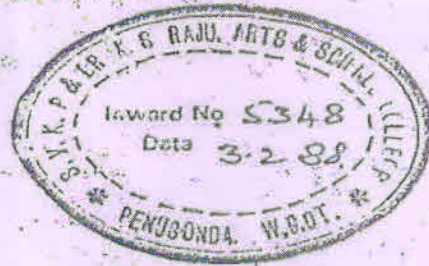

AFFILIATION TO B.Sc. (COMPUTER SCIENCE) COURSE.

A committee consisting of Prof. K.V.V. Ramana (Department
of Physics, Andhra University) and Prof. V.R.K. Murty (Department
of Computer Science and Engineering) have visited the SKVP and
K.S. Raju Arts and Science College, Penugonda for grant of permanent
affiliation for B.Sc. (Computer Science) during the year 1993-'94.

The committee has gone round the class room accommodation
laboratories, library, staff room, play-grounds, hostels and
other amenities in the college. The committee also had discussions
with the Principal and staff of the Computer Science and other
disciplines of the college.

The committee observed that:

1. The college has permanent buildings in which classroom
for B.Sc. (Computer Science) classes are provided.
2. The college has a Computer Science laboratory in a
30' x 20' hall in a permanent building with 4 PCXT'S
2 PCXT'S and 5 PC'S.
3. The College has an Electronics laboratory wherein 4 logic
trainers and 5 Microprocess kits are available to conduct micro
laboratory.
4. The college has 2 regularly appointed lectures: One
with B.Tech (Computer Science) and another with: M.Sc., M.S.
(BITS) one programmer and one Technical Assistant.
5. The college has a library with sufficient number of
manuals, books in the Computer Science subject.
6. The performance of the B.Sc. (Computer Science) students
from the college in the university examinations is satisfactory.

The college also has started a 3 year M.C.A. Course
to enable the B.Sc. students to further their academic career.

The committee, therefore, recommend grant of permanent
affiliation to the SKVP AND K.S. Raju Arts and Science College
for the B.Sc. (Maths, Physics and Computer Science) course from
the academic year 1993-'94.

The committee appreciates the cooperation extended
during their visit by the management and staff of the college.

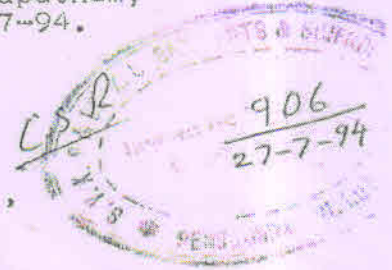

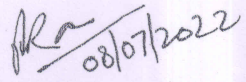
