 - (c) That no excess admission shall be made by the Institution over and above the approved intake under any circumstances. In case any excess admission is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution
 - **(f)** That the institutions shall not have any collaborative arrangements with any Indian and/ or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution
 - That the Institution shall not conduct any course(s) in the field of technical education **(g)** in the same premises/ campus and / or in the name of the Institution without prior permission/ approval of AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the
 - (h) The institution shall not conduct any non-technical course(s) in the same premise;/ campus under any circumstances. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the
- That the institution shall operate only from the approved location, and that the institution shall not open any off campus study centers/ extension centers directly or in collaboration with any other institution/ university/ organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.

- That the accounts of the Institution shall be audited annually by a control Chartered Chartered Accountant and shall be open for inspection by the Council or any body or per an auditorical by it.
- That the Director/ Principal and the teaching and other staff shall be selected according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the Council from time to time.
 - (d) That the institution shall furnish requisite returns and reports as desired by ACTF in order to ensure proper maintenance of administrative and academic standards.
 - (b) That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/ programmes being conducted and details of infrastructural facilities including faculty etc. In the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost base. The mandatory disclosure information shall be put on the Institution Clabsife. The information shall be revised every year with updated information about all aspects of the institution.

 - (e) That if Technical Institution fails to disclose the information or suppress and or misrepresent the information, appropriate action could be initiated including withdrawal of AICTE approval.

- That the AICTE may also conduct inspections with or without notifying the dates to verify specific complaints of mis-representation, violation of norms and standards, mal-practices etc.
- 13 That the Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid form the Central or State Government.
- That the Management shall strictly follow further conditions as may be specified by the Council from time to time.

In the event of non-compliance by the S V K P & Dr K S Raju Arts & Science College, Sy.No.133/1/2/3/12/13/67, Western Bank of Niddalore, Narsapur Land, Penugonda, West Godavari Dist. - 534 320 with regard to guidelines, norms and conditions prescribed from time to time the Council shall be free to take measures for withdrawal of its approval or recognition, without consideration of any related issues and that all liabilities arising out of such withdrawal would solely be that of S V K P & Dr K S Raju Arts & Science College, Sy.No.133/1/2/3/12/13/67, Western Bank of Niddalore, Narsapur Land, Penugonda, West Godavari Dist. - 534 320.
